CASH TREAT stalked the pace from the outside, moved up four wide into the upper stretch and finished gamely to just get up under all out pressure. RUNSANDYRUN pressed the pace while racing between rivals and finished willingly to the wire. OPERATOR ERROR showed good speed from the inside and weakened a bit in the drive. DEPUTY'S WHIRL dropped back early, saved ground throughout and showed good late interest. WA HOO ANGEL failed to respond. ROSAS AFFAIR dropped back early, was pulled up down the backstretch and had to be vanned off.
