DEFENDER'S WORD pressed the pace, saved ground throughout and finished gamely to be clear under all out pressure. CAPTAIN CUGAT was off slowly, moved up four wide at the eighth pole and finished gamely in the final stages. SHARP MOVE pressed the pace while racing three wide and weakened a bit in the lane. MFAZI was unhurried early, moved up four wide into the upper stretch and had no late winning bid. HIGH FLEET saved ground and never was a factor. THREE CHARMS dropped back early and never menaced. NAFIR'S LAD showed little. COUNT COUP set all the pace and tired readily.
