SHOWBOAT WILLY showed speed from inside rivals then shook free early in the first turn, continued on a wide lead into the lane and held safe under mild urging. TRIAGE steadied from tight quarters between rivals late in the first turn, moved inside going to the far turn while moving up and gained the place late. MFAZI rallied four wide into the lane and closed to just miss the place. WON FANCY DANCER rallied two and three wide in the far turn and lane to come up short in the minor placings. SNEAKALILPEAK chased the winner racing out from the rail, remained nearest that one into the lane then lost position late. POWDER RIVER CAT lacked a final closing response racing three to four wide. DAZZLE SOME tired from along the inside. GIFFORD ROAD chased the winner from along the inside to late backstretch and tired.
