### Footnotes

JAX MAXX was steadied off heels when keen to go on around the first turn, angled out for clear running entering the backstretch, commenced a three wide run leaving the far turn, closed steadily under right handed pressure, reeled in ELKHORN CREEK inside the sixteenth pole and edged clear. NINTH CLIENT, in closest pursuit of the free running leader, saved ground to upper stretch, angled out, rallied in tandem inside the winner past the furlong marker, steadied in deep stretch but recovered enough to earn the place. ELKHORN CREEK quickly cleared away, went free running down the backstretch to open up a large advantage, saved ground into the stretch, came under the whip near mid stretch and failed to last. TISNOW JULIE rated back from between rivals early, settled well off the early pace, angled four wide leaving the five sixteenths marker, circled into the stretch and closed steadily. SLICK VIC chased off the rail and retreated after six furlongs. SEGURO failed to menace. BRAVE TIGER saved ground early and tired.
