Footnotes

CORALINE stalked the pace well off the rail, assumed the lead in upper stretch and held sway under pressure. SPECTACULAR KIM , steadied when shuffled back by ROCKET TOCCET near the four and a half furlongs pole, saved ground on the turn, inherited the lead approaching the stretch, was no match for the winner, weakened and drifted out near the sixteenth pole. TAIGA GAL , fractious in the starting gate, lacked speed, saved ground and rallied. ATTEMPTING REENTRY , wide leaving the turn, was not a factor. BONNIE HEARS A HOO , unhurried early, raced slightly off the rail and weakened after a half mile. ROCKET TOCCET showed speed, drifted out leaving the backstretch then bolted on the turn. MAPLE LEAF RACER showed speed outside ROCKET TOCCET and was carried to the outside rail by that one leaving the turn. Following a stewards' inquiry, ROCKET TOCCET was disqualified and placed seventh.
