SMOKY OPAL moved up in the two path between horses leaving the turn, swung out in upper stretch, remained on her left lead, closed determinedly and drove clear late. BUTTERTART advanced in the two path between horses near the three eighths pole, opened up entering the stretch, remained on her left lead in the stretch and gave way grudgingly. SPRING DATE, three wide leaving the turn, drifted in in upper stretch, passed tired horses but was outrun. SUMMER COURT circled the turn in the three path and was outrun. CLEVER ANSWER saved ground on the turn and was outrun. IPANEMA BAY chased the pace three wide and faltered in upper stretch. FIVE STAR BREW, outside horses leaving the turn, was outrun. JUST BARELY stopped. HEALY HONEY showed speed along the rail and stopped.
