MADAM HERTFIELD stalked the pace, advanced three wide on the far turn and drew off through the stretch. MARTHAMOUNTAINMAMA disputed the pace, raced along the rail the final half mile and faded. CITI STATE , three wide the first turn, raced four wide the far turn and failed to sustain her bid. CALL MY LAWYER dropped back inside horses on the far turn, swung very wide in midstretch and showed late interest. FOR FUN , three wide between horses midway on the far turn, gave way in the stretch. FAIR AND LUCKY , outrun, raced wide. SUNDAY ROAR , three wide the first turn, disputed the pace and faltered.
