**Footnotes**

DRIVEN BY SAARLAND , behind horses on the turn, angled five wide approaching the stretch, was floated to the six path in upper stretch, swept to command approaching the eighth pole then drew off. GIRON circled the turn, raced six wide turning for home, was floated to the seven path in upper stretch and rallied. BREW FOR THE BAND , patiently handled, eased out to the six path in upper stretch and rallied. RUBIDIUM , four wide around the turn, dueled, drifted in near the eighth pole and weakened. TAHOE KID saved ground chasing the pace and faded. INSIDE THE PARKER , seven wide in upper stretch, passed tired foes. ROYALLY COOL disputed the pace two wide between horses and gave way. CLASSIC TIGER saved ground, dueled and gave way. TRAVELIN JOHN PAUL dueled three wide between horses and faltered.
