GULLY stalked the pace, circled the turn, challenged for the lead near the quarter pole, dueled through the stretch and gamely prevailed. SARGE'S disputed the pace two wide and just missed in a gutsy performance. R. B. FLOAT, wide on the turn, was in the five path near the quarter pole and failed to be a serious factor. NOBIZLIKEHORSEBIZ saved ground, dueled to upper stretch then weakened. IDLE LION, in the four path entering the stretch, gave way. KING'S RANSOM, a forward factor along the rail, was done early. NICKEL PLATE LINE, steadied leaving the starting gate, was outrun. CROWN COURT broke slowly and trailed.
