Footnotes

ANDRA , swung to the four path near the quarter pole, angled in approaching the eighth pole, closed along the rail and drove clear. HELP ME TO HELP U stalked the pace, circled the turn, was carried out a bit by DANCE RAVEN DANCE near the three sixteenths pole, gained the lead in midstretch and tired in the drive. DANCE RAVEN DANCE set the pace outside ROYALTY FOR ONE, bore in and bumped that one inside the quarter pole, swerved out near the three sixteenths pole and weakened the final furlong. ROYALTY FOR ONE , urged early after a slow start, hugged the rail, prompted the pace, was soundly bumped in upper stretch, steadied soon after and dropped back. QUEEN OF THE DISCO saved ground and gave way. LIUKIN , a forward factor early, raced in the two path on the turn and dropped back through the stretch. Following a stewards' inquiry, DANCE RAVEN DANCE was disqualified and placed fourth.
