PROUD OWNER saved ground under rating, moved closer into the far turn, rated back some near the three furlong marker, eased out in upper stretch, brushed SARATAGO FRIENDS when working her way between rivals in mid stretch, closed gamely and was along in the final strides. TOOKIN DOWN disputed the pace two to three wide, held a short lead in deep stretch but just failed to last in a game effort. INN BETWEEN stalked the pace between horses, advanced three wide into the lane, nearly drew even in mid stretch, dueled and continued willingly. SARATOGA FRIENDS raced under rating between rivals, angled four wide for the drive, was brushed and carried out some in mid stretch and flattened out. RAP AND DANCE was unhurried early, circled four wide into the lane and lacked the needed response. OCEAN PRINCESS set a pressured pace off the inside down the backstretch, dueled inside around the final turn, remained a factor to mid stretch then weakened. HOLIDAY BALL failed to menace. PROUD RUN stalked the pace four wide and tired nearing the lane. IN DUE TIME raced wide, faltered after a half mile, eased and was distanced. Following a stewards' inquiry and an objection by the rider of SARATOGA FRIENDS, PROUD OWNER was disqualified from first and placed fourth for interference in mid stretch.
