MEDIA ACCESS saved ground to the quarter pole, swung three wide at the head of the stretch, closed and drew out. WINDBORNE disputed the pace two wide and weakened. CARSONALITY prompted the pace along the rail and weakened. YOLANDA'S JUSTICE broke awkwardly, raced along the rail to midstretch, bore out and bumped STILL PROCEEDING near the sixteenth pole. STILL PROCEEDING raced in the two path on the turn, failed to threaten and was bumped near the sixteenth pole. THEOREM circled the turn and gave way. .
