### Footnotes

COASTAL DRIVE stalked the pace three wide, lodged a four wide bid entering the lane, took command in upper stretch, edged clear near the furlong marker, drifted out and held sway under a drive. STRIGHTUP TWELVE rated close up between rivals near the three eighths pole, shifted out in upper stretch, altered back inside of the winner leaving the eighth pole and finished gamely. UNADULTERATED prompted the pace along the rail, moved to near even terms entering the lane, vied to the three sixteenths marker then faded late. JUDGE MARSHALL lacked speed, came three wide for the drive and had some belated action. BRAVE CHARMER set a pressured pace two wide, dueled nearing the lane then tired in the final furlong. GREAT COMMANDER , sluggish from the gate, saved ground into the lane and failed to respond. DIXIELANDBANDITO , three to four wide, failed to keep pace and gave way.
