ANITA JOB , bumped and pinched back at the break, settled back early while saving some ground, eased out around the turn, swung out six wide for the drive, closed steadily under right handed pressure, lugged in while on her left lead the final sixteenth and edged clear late. SAVING ELENA broke inward bumping with the winner, was pinched back soon after, gained four wide leaving the three eighths pole, angled out wider continued a run into the stretch, rallied between rivals to be briefly on even terms near the sixteenth marker, was forced inward by the winner and battled gamely. HOLIDAY DREAMING stalked the pace three wide, moved to challenge nearing the quarter pole, dueled on a slim advantage past the furlong marker, faded and was briefly steadied late. BUNNY BLIZZARD stumbled at the break, hustled up to contention, chased inside rivals leaving the far turn, moved between foes to challenge entering the stretch, dueled to mid stretch then gave way. LOOKIN FOR ME drifted in at the break, was righted and sent clear, set the pace towards the inside, dueled inside horses from the quarter pole to mid stretch then weakened. CLOUDS OF TITIAN stalked the pace two wide and weakened. DON A BOO , bumped at the break, flashed speed inside and retreated. THISDANSEISTAKEN , three to four wide chasing the pace, dropped back after a half mile. An objection by the rider of SAVING ELENA against the winner for alleged interference leaving the gate was not allowed
