Footnotes

NO DISPUTE stalked the pace two wide under rating, lodged a bid entering the lane, put a head in front in mid stretch then steadily edged away under a drive. SKIT cleared early, set a slow pace along the inside, was collared by the winner in upper stretch, dueled past the eighth pole then gave way grudgingly. COUNTY RECOUNT , six wide into the first turn, settled well off the rail, advanced four wide into the stretch, and rallied mildly. REGAL MEG steadied at the break, was unhurried early, circled five wide under urging around the final turn and slowly gained. COMPADRE'S PEACH lacked speed, made a mild inside run into the lane then flattened out. BLUEBIRD'S SONG saved ground early while lacking speed, angled out around the final turn and lacked a solid response. PAPA'S PUMPKIN saved ground, moved up into the far turn, chased the pace around the final turn and tired. LADY CONVEYOR stalked the pace three wide and faltered before going six furlongs. BOLD MEGHAN , seven wide into the first turn, continued very wide down the backstretch but failed to threaten. BRIDAL BALLAD , four wide, dropped back entering the far turn.
