SAY NOW took dead aim four wide off the dueling leaders, moved closer under a light hold mid turn, overtook CALVIN B leaving the quarter, opened up under solid right handed pressure then was fully extended to hold off URBAN JUNGLE. URBAN JUNGLE was rated back from between rivals early then settled back off the rail, came five wide for the drive and closed gamely through the final furlong to nearly get up. TEA TOTT , bumped at the break, recovered and moved within range early while four wide, commenced a run three furlongs out, continued willingly to mid stretch then flattened out late. CALVIN B dueled in the three path while on a short lead, continued in front while between rivals nearing the three eighths pole, battled inside the winner into the lane then gradually gave way the final eighth. LION DRAWING disputed the pace two wide and inside CALVIN B dropped back some nearing the lane, altered out wide in the drive but failed to generate a solid kick. TACTICAL STING , wide to the turn, was outrun. KYLE'S ROYALTY , well placed saving ground stalking the early pace, was roused around the turn and gave way. MALA MALA CAT lacked speed while saving ground early, angled wide around the turn, faltered and was eased late.
