WINNING DRIVE , three wide around the turn, chased the pace, gained command in upper stretch and eagerly pulled away under vigorous rousing. STONE IN LOVE chased the pace outside COOPER COUNTY, gained a short lead at the head of the stretch, finished gamely but was no match for the winner. PENITANT PRAYERS lacked speed, floated to the five path entering the stretch then had a slight rally. C'MON MAN broke awkwardly losing his best chance, raced in the four path between horses entering the stretch and failed to be a factor. MUSCADINE , angled in entering the turn, saved ground and was not a factor. COURTING WISDOM , in the two path on the turn, drifted to the three lane entering the stretch then gave way. SUDDEN SHIFT , wide turning for home, was outrun. COOPER COUNTY sped to the early lead, set the pace along the rail and faltered in midstretch.
