GOING TO MARKET, taken to rate removed from the inside, moved up three wide into the far turn to engage BIG MONSTER, dueled outside that one while under a ride, took a short lead in upper stretch, continued to duel past the furlong marker then widened the final sixteenth under a drive. BIG MONSTER opened up early, set the pace towards the inside, was joined around the far turn, dueled inside the winner, faded but was clearly best of the rest. LAWYER DAVE settled three wide early while off the pace, was put to a drive leaving the far turn, made a mild gain in mid stretch then flattened out. TENNESSEE BEND broke a step slow, lagged back while saving ground and passed tiring rivals. ST. JOHNSWOOD was angled in when pulling his way forward leaving the seven eighths pole, stalked the pace, edged closer after a half mile, chased the leader to the three furlong pole then retreated. INDIANA MOON faltered after a half mile and drifted out very wide entering the lane.
