ELFIN JEN rated off the early pace inside, angled five wide nearing the quarter pole, advanced to the lead midstretch and cleared soon afterward. GOLDEN HOTTIE chased the pace while off the rail, was hemmed in nearing the quarter pole, bumped off stride in midstretch and recovered enough momentum to regain a clear place. STRATAFIED rated off the pace about the four path, angled out entering the stretch and finished evenly for show. IMP ON THE RUN rated close to the pace while off the rail, moved to even terms near the five sixteenths pole, dueled with a slight disadvantage from the quarter pole, had a very brief short lead near the eighth pole but weakened from there. EASY WINNER rated off the pace about the three path, angled four wide at the quarter pole then flattened stride through the lane. FAMILY VOW showed no speed inside and passed tiring rivals. NOTE D'AMOUR saved ground while showing no speed early on, angled out for the drive and had no rally. DAGGERS'N CLAWS was steadied when forced in at the start. JETTA'S JOURNEY broke inward, immediately recovered stride to take the early lead inside, contested the rail near the five sixteenths pole, came out a half path making solid contact with Golden Hottie in midstretch and gave way from there. The stewards reviewed the incident in midstretch and found no cause to make a change.
