**Footnotes**

NASDAQ QUEEN pressed the pace two wide, gained command in upper stretch, came in a bit nearing mid stretch, drifted in when clear nearing the sixteenth marker and held sway under a drive. BUGSY PARK was sent from the gate, set a pressured pace inside, took an awkward stride when switching her leads nearing the lane, checked when in tight nearing mid stretch, altered course to the outside and finished willingly. SHERMAN ACT saved ground and lacked a solid bid. WEWE C angled in early, came off the rail nearing the lane and lacked a bid. B L'S LADY JOANN, between rivals early, angled out four wide entering the lane and faded. TWO KARAT CHICK broke a step slow, never threatened and raced five wide in upper stretch. There was a stewards inquiry and objection by the rider of BUGSY PARK against the winner for alleged interference in the stretch. No action was taken.
