**Footnotes**

CAYMAN CONDO rated off the pace about the four path, moved alongside the top two three wide nearing the quarter pole, dueled to the lead midstretch and edged away the final sixteenth. SHAMSS showed no speed inside, advanced along the rail through the turn, eased out entering the stretch and was up late for place. BEAT THE CHALK hustled up inside to take over approaching the seven sixteenths pole, contested the rail through the turn, dug in close to midstretch and gradually weakened from there. RUFFLES AND RIDGES chased the pace inside, eased out midstretch and finished evenly mid track. BRESKO hustled to a brief early lead off the rail, gave chase through the turn, remained close between horses in the upper stretch then weakened passing the eighth pole. SANDBAGGER JONES dropped back early on and never factored. BLACK AND AMBER showed only brief speed from the outside before fading. SEA HERO'S GHOST chased the pace about the three path and had no further response on the turn.
