Footnotes

LIPSTICK TRACES stalked the pace, advanced four wide leaving the turn, swept to command in upper stretch and drew out while kept to her business. PARADE OF COLORS , in the three path entering the lane, rallied between horses. CALOCAGATHIA , steadied when pinched back leaving the starting gate, swung to the six path entering the stretch then rallied gamely. DISCO DORA , in the five path turning for home, advanced to midstretch then failed to sustain her bid. QUIET WAVE , in the four path in upper stretch, finished willingly between horses. SIMPLE CAT , in the two path leaving the turn, finished willingly between rivals. BEE TOUCHED rushed up three wide to gain the lead entering the turn, was clear leaving the bend and tired in the drive. ARUBA , swung wide in upper stretch, was outrun. VOEUX prompted the pace two wide and gave way. SHARP DAY had speed along the rail and faltered. LIMEHEART saved ground and faltered.
