PENNIES APPEAL was rated back after an alert start, sat patiently towards the inside around the turn, swung out for clear sailing into the lane, closed sharply under left handed pressure, forged past MERRY LYNN leaving the sixteenth marker and eagerly widened. MERRY LYNN , a bit rank under firm restraint early, prompted the pace two wide, moved to challenge leaving the five sixteenths pole, spurted away when roused in upper stretch, widened a furlong out, continued willingly but was no match. AWESOME FLOWER , three to four wide stalking the pace, lacked a rally. FANTASY FOREST cleared early and angled in, set a rated pace, was taken on leaving the five sixteenths marker, gave some resistance into the lane and tired.
