Footnotes

WORLIDLY PLEASURE advanced along the inside entering the turn, rated close up, angled out near mid stretch, closed steadily between rivals inside the sixteenth marker and drew clear under a drive. GAMBLE'S ANSWER rated close up in the two path, angled out in upper stretch, closed willingly and gained the place. QUICK SMOKE , brushed at the break, advanced inside of FIT TO KILL to take command near the four and a half furlong marker, set a slow pace, came two wide for the drive, held a clear advantage past the eighth pole but could not last. ISLAND MELODY lacked speed, began a steady run leaving the five sixteenths marker then was forced out by FIT TO KILL entering the lane. RIDAN'S MON tracked the pace three to four wide, was bumped and forced out entering the lane and dropped back. FIT TO KILL broke on top and held the early advantage, prompted the pace two to three wide around the turn then broke down entering the stretch. A stewards' inquiry was posted concerning FIT TO KILL but no action was taken.
