### Footnotes

WICKED THUNDER cruised up from the outside to take command early turn, edged clear after three furlongs, met the oncoming challenge of LOVE TALK in upper stretch, dueled, drifted out under left handed pressure, was corrected soon after and dug in under steady hand urging late. LOVE TALK, in close soon after the break, was guided out four wide nearing the turn, made a bold run into the lane, engaged the winner in mid stretch, dueled, was floated out a bit and kept on gamely to just miss. PETER'S CREEK, bumped and forced in a bit at the break, gained four wide behind LOVE TALK nearing the stretch, gave chase to mid stretch, shifted in and lacked the needed finish. YANO stalked the pace, edged closer three wide between runners near the stretch, failed to sustain and faded in the last furlong. LEMON JUICE saved ground early, angled two wide, made a slight gain approaching the lane then flattened out. BOREAL FOREST sprinted clear early, set the pace inside, was overtaken leaving the far turn, gave brief chase and faltered. HEY DOC HOLIDAY drifted in at the break, gave wide chase and faltered.
