### Footnotes

LEGALLY INCLUDED , bumped at the break, settled off the pace while saving ground, edged closer mid way on the final turn, got through along the rail launching a bid in upper stretch, took over nearing the eighth pole, was joined outside by CHANTERELLE, responded to solid handling and held that one at bay. CHANTERELLE stalked the the pace two wide moved closer into the far turn, really did not kick when first put to a drive between runners leaving the far turn, shifted in a bit giving pursuit into the lane, came back outside the winner to challenge in mid stretch, battled gamely but was denied. TWO HEARTS IN ONE bumped with HOT SPICE GIRL nearing the first turn, angled out for the backstretch run, gained nearing the far turn, shifted in and overtook a tiring rival for the show. AWESOME AND CLASSY cleared early, set a slow pace along the inside, was nudged along into the far turn, was joined after six furlongs, drifted out three wide entering the lane, held well to mid stretch then faded. HYPATIA'S SKY fought restraint when keen to go on near the seven and a half furlong marker, was guided outside and settled better, moved up around the far turn, bid outside the pace setter after six furlongs, was all in pressing the pace after six and a half furlongs then tired in the last eighth. HOT SPICE GIRL , bumped at the break, was in close when making contact with TWO HEARTS IN ONE entering the clubhouse turn, settled inside past the three quarter pole, was taken wide for the run around the final turn, made a slight bid after six furlongs then had nothing to give in the final three sixteenths.
