MY CUZ C J prompted the pace four wide outside KENS CAPE, raced between rivals nearing the lane, eased back a bit and gave chase leaving the three sixteenths marker, alter in some past the furlong maker, came back under strong left handed urging, took command late and was edging away. KENS CAPE took command at once, set a moderate pace in the three path, took pressure around the turn, edged back clear in the four path near the furlong marker, continued gamely but was no match late. CONGRESSIONAL PAGE was rated back early and settled off the rail, responded when asked past the three eighths pole, rolled up five wide to engage KENS CAPE after a half mile, forced the issue to mid stretch then failed to sustain. BROAD RULE saved ground chasing the pace and lacked a bid. MEGA MOOSE dropped back far back.
