**Footnotes**

DREAM OF SCIPIO bumped ST LIAMS HALO when bearing in leaving the starting gate, accelerated to the early lead, set the pace in the two path and dug in tenaciously late to prevail. YUKON SPECIAL, a forward factor along the rail, was in hand waiting for home entering the stretch, steadied behind the winner in midstretch, angled out near the sixteenth pole and flattened out. BELLISSIMA LUNA chased the pace three wide, was in range of the leader turning for home then failed to rally. FOREST JUSTICE, three deep turning for home, drifted to the five path in midstretch and lacked the necessary response. ISOLATION ROAD lacked speed, raced along the rail on the turn, eased out to the two path entering the stretch and failed to be a factor. ST LIAMS HALO, bumped leaving the starting gate, hugged the rail on the turn and was outrun. REASON TO DRINK, rank leaving the starting gate, raced wide leaving the turn and was not a factor.
