**Footnotes**

AMBER JULE , unhurried early, circled the turn, took command in upper stretch and drew off under a hand ride. H. R. H. DOODLE , two wide between horses on the turn, prompted the pace and weakened. GONNABEAPARTOFIT , three wide on the turn, rallied mildly. TRUE FACTS , two wide around the turn, failed to rally. HAVEYOUHEARD , unhurried early, raced wide and was no factor. TEEQUA set the pace along the rail and gave way. RIDGE COURT LADY was done early. GRAND SCHEME , outrun, raced wide in the stretch. IN TUNE raced along the rail, stopped and was eased.
