PROUD PEARL , patiently handled in a forward position removed from the rail, edged up between rivals mid turn, came four wide for the drive, altered out and responded when put to the whip inside the three sixteenths marker, closed determinedly when her rider switched to the right stick and forged ahead of DOE in the final strides. DOE prompted the pace about four wide and under rating, moved to collar PRINCESS MEDORA leaving the three eighths pole, opened up a solid advantage under pressure a furlong out, switched to her left lead late and failed to last. SNOW FLURRY saved ground throughout, moved up mid turn, challenged briefly near the quarter pole but failed to sustain in the drive. MISS PAVAROTTI settled within range while well off the rail, made progress five wide approaching the stretch, failed to go on when called upon and tired through the final furlong. PRINCESS MEDORA moved clear past the three quarter pole, set a moderate pace under some rating, entered the lane three wide and faltered past the quarter pole.
