### Footnotes

GIMMESOMEACTION settled back off of a contested early pace, angled out and picked up momentum four wide leaving the far turn, was under a strong ride leaving the five sixteenths marker, rallied under left landed pressure to take command a sixteenth out then edged clear late. QUEEN OF CHENA , unhurried early while off the rail, circled five wide into the stretch and closed willingly to just get the place. DOADEERAFEMALEDEER , allowed to settle while saving ground, continued inside around the final turn, angled out in upper stretch and worked her way between rivals in the final furlong. BETRAYED stalked the early duel while off the rail, came three to four wide for the drive and finished willingly between horses. U. K. GIRL , four wide early, dueled three wide in early backstretch, moved clear after a half mile, edged away around the final turn, continued well clear past the eighth pole, gave little resistance when collared a sixteenth out and tired. CHURCH BELLS dueled two wide inside U.K. GIRL through the opening three and a half furlongs, rated back off that one after a half, chased to the quarter pole then tired. CAKE WALK , well placed towards the inside, made a mild advance near the far turn, remained forward for six furlongs then faltered.
