### Footnotes

FINGERSNAPPER , four wide between rivals into the far turn, came four wide under a ride into the lane, closed under strong handling to collar POLITELYPRECOCIOUS a sixteenth out, dueled and narrowly prevailed. POLITELYPRECOCIOUS was gunned up inside after breaking a tad slow, set the pace towards the inside, moved away when roused in upper stretch, drifted out some nearing mid stretch, met the challenge of the winner a sixteenth out, dueled inside that one battled gamely to just miss. GRANDILOQUENT , three wide between rivals, made a mild run near the furlong marker then flattened out. DAYDREAMIN GRACIE saved ground off the pace, was asked for run mid turn, shifted out and failed to mount a serious run. MON CHOU , five wide outside rivals, moved up some after a half mile, chased the leader into the lane then faded. GREEN WAVE GIRL failed to menace. NEXT LEVEL , away alertly, prompted the pace outside the leader, made a mild bid mid turn, chased into the lane then gave way the final furlong.
