ISSUES AND ANSWERS settled back off the rail and off of a spirited duel, commenced a run under some coaxing leaving the three eighths pole, was put to a full drive in upper stretch, rallied five wide past the dueling leaders in mid stretch, quickly opened up a clear advantage and held firm. VARBOROUGH lagged well off the early pace, saved ground under a drive into the lane, was maneuvered out to about the five path leaving mid stretch and finished up willingly to earn the place. PETECAROL dueled outside BILLY CHAPEL through rapid fractions, gained a short lead while drifting four wide into the stretch, continued to battle past the eighth pole then gave way grudgingly. BILLY CHAPEL was sent up inside PETECAROL leaving the chute, alternated the lead with that rival, came out under left handed pressure impeding GROOVY MUSIC near the furlong marker then faded. RAM , removed from the inside, lacked a bid. GROOVY MUSIC , well placed off the dueling leaders, angled off the inside entering the stretch, clipped heels when trying to advance between foes in mid stretch then gave way. Following a stewards' inquiry and objection by the rider of GROOVY MUSIC, BILLY CHAPEL was disqualified from fourth and placed last due to causing interference in mid stretch. An objection by the rider of GROOVY MUSIC against PETECAROL for alleged interference in mid stretch was not allowed.
