EIGHTTOFASTTOCATCH stalked the pace, advanced three wide to gain a short lead near the three eighths pole, dueled with MARILYN'S GUY through the stretch, was bumped by that one approaching the eight pole then prevailed in a hard drive. MARILYN'S GUY saved ground prompting the pace, bid for the lead near the three eighths pole, dueled inside the winner, drifted out and bumped that one approaching the eighth pole and continued gamely to the wire. NO ADVANTAGE drifted out entering the first turn, lacked speed, raced wide turning for home and faltered in upper stretch. ROYAL CLASH, carried wide by NO ADVANTAGE entering the first turn, was outrun and saved ground around the far turn. ALMA D'ORO set the pace in the two path, surrendered entering the stretch and dropped back through the lane. An objection by the rider of ROYAL CLASH against NO ADVANTAGE for alleged interference on the first turn was not allowed.
