Footnotes

OFFICIOUS hugged the rail stalking the duel, eased out to the three path when commencing his rally turning for home, closed outside rivals and drove clear late. ESPIRITU LIBRE saved ground disputing the pace, weakened and drifted out near the wire. THE MAN'S HOSS disputed the pace outside ESPIRITU LIBRE and surrendered the final sixteenth of a mile. JUDGE WYLIE , four wide leaving the turn, raced on his left lead in the stretch and failed to rally. FINAL VINDICATION chased the pace two wide and gave way on the turn. RELENTLESS REPENT saved ground and was not a factor. KODIAK SONG , outrun, circled the turn three wide. STRONG SHAFT raced along the rail and dropped back entering the turn.
