CLOSED COURT set the pace along the rail and eagerly pulled away under energetic urging. HOT ALLIANCE lacked speed, raced near the rail and had a mild rally. DEMONS DIAMOND raced along the rail on the turn, drifted wide in midstretch and passed tired ones. GOTTALOTTACHARM lacked speed, raced wide in the stretch and passed tired horses. QUOIT A BET failed to make the early lead despite brisk urging, was steadied between horses near the half mile pole, chased the winner two wide and gave way in midstretch. LUCY LOVESALOT raced along the rail, chased the winner and gave way. BUBBLE TROUBLE , swung to the three path entering the stretch, gave way. ROBIN DES CONCORDE circled the turn, raced wide entering the stretch and gave way. EMBLEM'S THIN MINT , wide, trailed.
