MIDNIGHT FLAIR, unhurried off the rail, angled four wide leaving the quarter pole, came inside the runner-up midstretch and ran that one down passing the sixteenth pole. WESTON FIELD rated back about the three path, bid nearing the five sixteenths pole, came out in the upper stretch, reached the pacesetter and a short brief lead at the sixteenth pole but was outfinished from there. NIGHTTIME DANCER rated off the pace inside and leveled off through the lane. EAGLE BEAGLE rated back toward the outside and bid mildly in the stretch. LORD BARRISTER drew to a long early lead inside but grew weary just inside the eighth pole. WANAKA steadied briefly at the start, gave chase off the rail, came through the turn five wide then weakened in the lane. TEMPORARY SETBACK never factored.
