Footnotes

NAVAHO WARRIOR circled the turn, chased the pace, gained command in upper stretch then drew out under pressure. SNEAKY GENERAL stalked the pace two wide, reached contention in midstretch then failed to sustain his bid. FULFILLING DREAM disputed the pace two wide and weakened. JOHNNAMEDMECLARK saved ground around the turn and was not a late threat. DUTCH PURPLE , wide around the turn, was fanned five wide entering the stretch and was not a factor. KUDZU was outrun. TIGGER TOO , six wide turning for home, was outrun. AMERICAN CHIEF saved ground, disputed the pace and gave way. SEEKING A RAINBOW , taken up in tight quarters entering the turn, drifted five wide leaving the turn and stopped. An objection by the rider of SEEKING A RAINBOW against the winner for alleged interference entering the turn was not allowed.
