### Footnotes

ALTERNATING BASS set the pace well off the rail and lasted under energetic urging. ROI D'ETOILES saved ground around the turn, eased off the rail in upper stretch and rallied between horses. ONE HUNDRED LAUGHS saved ground, chased the pace and flattened out. PAST THE REWARD, wide turning for home, flattened out. VANSLITTLEBOY, swung wide near the eighth pole, passed tired foes. QUARRY LAKE, outside the winner, chased the pace and weakened. ROSCOMMON COUNTY chased the pace, raced wide turning for home and gave way. NIKI HOTWHEELS was outrun. JAZZKING, wide leaving the backstretch, gave way. PRIME LEADER was outrun.
