Footnotes

NOLL WALLOP (IRE) lacked speed, moved up outside horses in upper stretch, was floated to the eight path in midstretch, continued his rally and was along in time. FANTASTIC SONG , unhurried early, raced between horses in the stretch, was in the seven path in midstretch and finished gamely to just miss. POWDER MOUNTAIN , three wide the first turn, moved up four wide entering the stretch, drifted to the six path in midstretch and flattened out. EL SEASON stalked the pace, was in the four path between horses in midstretch and finished willingly. CAPITAL FELLOW chased the pace, had aim in the three path in midstretch then weakened in the drive. SIR RABBIT , in the two path in the stretch, closed the gap late. BROXBORNE , in the six path in midstretch, was never a threat. SLAMBINO was not a factor. ELKHORN CREEK sped to the front, set the pace along the rail and gave way in the drive. MOVING WEST , forwardly placed early, faltered in upper stretch.
