Footnotes

TINTIM POR TINTIM prompted the pace three wide, secured command approaching the three eighths pole, steadily pulled away under urging and drifted out in midstretch. OUR COMMANDER dueled two wide, weakened and held the place. GO MAIRE TU , two wide in midstretch, had a mild rally. MUSCADINE , angled out in upper stretch, had a slight rally. QUICK APPEAL , along the rail entering the turn, swung out leaving the turn and failed to sustain his bid. FLYING PUNCH saved ground, disputed the pace to upper stretch then faded. JAZZ SEEKER , well off the rail, turned in a dull showing. BETH'S MARK , outrun, saved ground. DALE'S HONEY , outrun, very wide around the turn and was eased the final furlong. JOEL'S TOUCH stalked the pace, drifted wide entering the stretch and faltered.
