HURRICANE GIRL assumed a clear, early lead, set the pace along the rail and increased her advantage through the stretch sans whipping. BANNER ELK LADY, in the two path between horses on the turn, chased the winner and faded in the drive. PARADE OF HOMES, four wide on the turn, advanced to the stretch then failed to sustain her bid. NAMASKARA lacked speed, raced in the two path between horses on the turn, swung wide in midstretch and passed tired rivals. BRUSHED BY LOVE saved ground and was not a factor. HEAVEN'S VOICE hugged the rail, chased the pace and faltered. HEAVENLY CHOIR came out leaving the starting gate, chased the pace three wide on the turn and weakened. EASY ENIGMA stumbled leaving the starting gate and was outrun.
