COWBOY BILL, unhurried early, saved ground, eased out near the sixteenth pole, closed and was hard ridden an additional sixteenth of a mile. WING WALKER lacked speed, swung very wide in upper stretch and rallied. CRYPTO PRIME raced between horses and flattened out. BEAN, wide the far turn, failed to rally. DELTA MOON was steadied behind horses entering the first turn. DOMENICK'S DUNE disputed the pace two wide and faltered. FRIENDLY SEA dueled along the rail and faltered. DELTA PARK, far back, was eased.
