JU JITSU JAX , a bit fractious pre race, broke outward and was away a step slow, advanced four wide leaving the three eighths pole, moved to command in upper stretch, drifted in some near the eighth pole then edged away under a steady drive. RAGING RON rated off the early pace, made a quick rail move near the three eighths pole, angled out mid turn, lodged a bid between rivals nearing the lane, battled inside the winner near the eighth pole and stayed on gamely to be well clear for the place. DAVE'S RESURECTION , taken to rate while saving ground, continued inside into the lane, angled out near mid stretch and passed tired rivals to get the show. CRAFTY LION stalked the pace, raced three wide past the three eighths pole, gained some ground nearing the lane then weakened in the final furlong. FAST COUNTY opened up early, set the pace inside to upper stretch then faltered.
