GRAEMY , three wide between rivals early, was shuffled back entering the turn, recovered to angle out and rally five wide entering the stretch, lodged a bid in mid stretch, drifted in a bit when taking a short lead soon after, dueled and proved best under right handed pressure. KITTY CITY , bumped and in close entering the turn, moved up between rivals past the five sixteenths marker, angled to the rail entering the stretch, bid to near even terms leaving the eighth pole, dueled inside the winner and stayed on well. CAKE WALK , hustled to the front, set a pressured pace off the rail, was taken on from both sides nearing the eighth pole, dueled briefly then weakened late while drifting out. DANCE WITH JAMES , outrun early while saving ground, swung out five to six wide for the drive and had some belated action. DISCOS WISH moved up four wide past the five eighths pole to reach contention, pressed the pace three wide around the turn, continued a forward presence for nearly five furlongs then gave way. L P'S TIGER saved ground in a forward position past the five eighths pole, steadied when bumped soundly entering the turn, chased around the turn, angled out for the drive and weakened. EMPRESS LISA bobbled inward at the break, raced off the rail and failed to menace. WILLOW CREEK lost ground four wide stalking the pace, remained a factor to the head of the lane, raced on her left lead and tired.
