Footnotes

BIG M J prompted the pace three wide, bid for the lead leaving the turn and drew clear under brisk urging. DYLAN RAY worked between horses on the turn, had aim on the leader in midstretch then flattened out. MONTY'S APPEAL, wide around the turn, chased the pace and finished willingly. FOUR X THE TROUBLE, taken up in tight quarters near the quarter pole, angled out and finished gamely. MAGNIFICODE saved ground on the turn, came off the rail entering the stretch and failed to rally. DIAMOND COUNTY, behind horses entering the turn, raced very wide leaving the turn and failed to be a factor. TED'S VISION was outrun. DEFUSE DEBEAST was outrun. GO SIX GO disputed the pace two wide between horses and gave way. COOL DADDY dueled along the rail and stopped in upper stretch. WIRE FUNDS broke slowly and trailed.
