Footnotes

SKIP THE TRIAL was taken to rate off of a contested pace, angled out five wide for the drive, closed well under right handed urging, surged past the dueling leaders inside the sixteenth pole and drew clear. VERIFICADOR prompted the pace four wide, bid to challenge entering the lane, gained a short lead approaching the eighth pole, dueled and stayed on well to save the place. BLADE MARTIN , forwardly placed two wide into the turn, angled in three furlongs out, bid to challenge into the lane, dueled past the eighth pole and gave way grudgingly. ONE TO A ROYAL disputed the pace in the three path, moved clear mid turn, was taken on near the quarter pole, dueled between rivals past the eighth pole and gave way grudgingly. MO'S BRO broke slowly and failed to menace. FOOLIN' THEXPERTS vied along the rail into the turn and faltered.
