CASANOVA JACK stalked the pace near the rail, swung four wide leaving the turn, closed steadily and narrowly prevailed. HEAVYWEIGHT circled the turn, took the lead approaching the stretch and gave way grudgingly. SKELETON CREW hugged the rail to the three sixteenths pole, angled to the five path near the eighth pole and rallied. SWAMPY TOWN showed speed in the two path and weakened in the drive. BEER STIEN broke slowly, raced between horses entering the stretch, swung very wide in midstretch and rallied. HOUND lacked speed, raced between horses in the stretch and failed to be a factor. NORTHEASTERN was outrun. HANKY PANK , very wide entering the stretch, was not a factor. THE STALKER , five wide entering the stretch, gave way. CHAMACO LOCO hugged the rail and was no factor.
