X MARKS THE SPOT stalked the early pace while off the rail, was urged along on the turn, came four wide for the drive, drifted in while rallying in mid stretch, took command inside the sixteenth pole, edged clear and proved best under a drive. CREVE COEUR stalked the early pace, was steadied between rivals in mid stretch, shifted out near the sixteenth marker and closed willingly. PREFERRED LENDER sprinted clear, set a rapid pace, opened up around the turn, raced two wide in upper stretch, was collared in the final sixteenth and weakened very late. POWER NUMBERS saved ground, advanced into the lane but lacked a solid finishing response. OUR BOLD ENSIGN , in mid pack, failed to respond. I DOT saved ground and came up empty. APPEALING SPEED lost ground four wide. JAZZ STATION , outrun early, came five wide for the drive and lacked a rally. BOOGYMAN saved ground into the lane and failed to menace. SOUND MOON , sluggish from the gate, was outrun. Following an objection by the rider of CREVE COEUR, X MARKS THE SPOT was disqualified from first and placed second for interference in the stretch
