Footnotes

LEGAL TROUBLE cleared early, set a rated pace inside, repelled a challenge leaving the far turn, widened in mid stretch and held sway under a drive. HAYNES HILL broke slowly, came four wide for the drive and closed willingly to get up for the place. TIGGER TOO , between rivals early stalking the pace, lodged a bid around the far turn, chased the winner into the lane and was outfinished for the place. PASSIONATE HALO , within range, made a mild move leaving the far turn, came four wide for the drive but lacked a solid finish. KNOCK DOC saved ground and lacked the needed response. TALL TURF , four wide early, stalked the pace three wide around the turn and tired. MOON DRIVE chased the early pace and faltered. CLINTS PLEASURE lacked speed, came four wide for the drive and failed to threaten. MIZZEN MOST was outrun. SEA PROSPECTOR dropped back.
